Power of Attorney

Power of attorney ej pepa eo armej (nae etal principalak jinen/jemen) ej lelok nan juon armej remaron tomak e (nae etan ejen. Power of attorney eo ej kotlak an ejen eo komane kelet ikijen jikin takto ak treatment ak madmod e business ko ilo etan principal(jinen/jemen) eo.

Ekke an power of attorney jemlak ne jinen/jemen ejabwe jela eo am. Ijo wot ke, ne power of attorney eo "ekajur" im enej eman jakdron ne jinen/jemen ejabwe jela eo aer.

Durable powers of attorney rej koman ne armej eo ewor an medical treatment ak luuji kolmenlakjen eoam. Armej eo ej aikujin maron/ewor an jela ilo ien an jaini power of attorney bwe pepa in en maron valid.

Maron ko an power of attorney ion kartienjep ej:

- Jinen/jemen ewor aer maron nan won eo ej lelok power of attorney
- Jinen/jemen emaron kojemlak power of attorney jabrewot ien
- kojjab aikujin etal nan court nan bok power of attorney
- Ejelok rietale yuk jen court enej aikujin
- Ejjab lap wonen

Living Will

Armej eo ewor an jimwe in koman an statement, nae etal living will, im ej kwalok konan ko aer nan men ko mweier ak withdraw life-sustaining treatment. Pepa/forms kein rebojak nan am kanni im lelok nan takto eo am.

Pepa in ak living will in emaron wot ijinoe ne kwoj jinoe naninmej ak takto emoj an ba ke:

- Elap am naninmej
- Kwojjab maron koman am makke kelet
- Ko kiki jajelakjen

Pepa in ak living will emaron wot ablae nan kelet eo ikijen medical eo am. Ejjab lukun mool in "will" im eban kelet won eo enej bok eddo in men ko mweiem.
